As per Section 25.4. of the 2016 Revised IRR of RA 9184, The second envelope shall contain the financial information/documents as specified in the PBDs.
			BAC shall adhere to the 2016 Revised IRR of RA 9184 and any discrepancies in the Instruction to Bidders, the 2016 Revised IRR of RA 9184 will prevail. Clarification(s) on any part of the Bidding Documents or for an interpretation must be in writing and submitted to the Procuring Entity at least ten (10) calendar days before the deadline set for the submission and receipt of Bids.
