- 4. Request for extension shall be made prior to the expiry of 45-calendar day period.
- 5. Expiration period of chemicals involved shall be one (1) year upon receipt of the items.
- 6. Additional clarifications can be made within three (3) days after the pre-bid conference and must be in writing addressed to the BAC.
