			<ul style="list-style-type: none"> <li>➤ All forms of bid security are acceptable however if the Bidder opts to submit a Surety Bond it must be callable on demand and must be accompanied by (1) Certificate of Authority from the Insurance Commission authorizing the Insurance/Finance Company to issue such bond and (2) another Certification for the surety bond from the Insurance Commission for bidding purpose of the specific project. A new form of bid security which is Bid Securing Declaration is acceptable, pursuant to GPPB Resolution No. 03-2012 dated January 27, 2012.</li> <li>➤ Proper tabbing of bid documents must be observed by the bidders.</li> <li>➤ The bidders are advised to observe the Bid Prices found in the ITB Clause 15.</li> <li>➤ The bidders are advised to observe the Format and Signing of Bids found in the ITB Clause 19.</li> <li>➤ The bidders are advised to observe the Sealing and Marking of Bids found in the ITB Clause 20.</li> </ul>
