- A. Pre-Bid Conference under Public Bidding for Purchase Requisition No. 20-0042 Supply & Delivery of Air Compressor & Pneumatic Pavement Breaker to be used by WSCIS of the Customer Service Division
- 1. Letter of Invitation was sent to COA and observers, however no observers were present for the pre-bid conference.
- 2. Vice-Chairperson Aguilera said that the Approved Budget Cost is in the amount of One Million Six Hundred Thirty Thousand Pesos (P 1,630,000.00).
- 3. Bid opening will be on March 31, 2020.
- 4. Similar contract shall refer to Air Compressor & Pneumatic Pavement Breaker.

- 5. Vice-Chairperson Aguilera read through the specifications of Air Compressor and Pneumatic Pavement Breaker.
- 6. Mr. Arnold Tacadao, bidder representative from Janglo Construction commented that the specification for compressor are fixed, the range for BHP was not specified.
