The winning bidder can follow the original delivery schedules as stated in the Schedule of Requirements. However, the winning bidder shall have the option to deliver a minimum of 1000 bags and a maximum of 2,000 bags of Aluminum Sulfate per delivery.  Bidders are still required to deliver the minimum number of bags per delivery. Excess number of bags delivered shall not be deducted from the minimum bags required for the succeeding deliveries except when the remaining number of bags for the next delivery is less than the outstanding number of bags to be delivered due to previous excess deliveries.

21-0021	Supply & Delivery 1,500 drums Liquid Poly Aluminum Chloride (PAC) at 200 Liters/Drum content only for water treatment use	•	Must submit 1 Liter sample during opening of bids.  The submission of third-party Test Result for Liquid PAC during bid opening shall be revised as agreed during the pre-bid conference, instead, it shall be submitted by the lowest calculated bidder during post-qualification.
		•	The winning bidder can follow the original delivery schedules as stated in the Schedule of Requirements. However, the winning bidder shall have the option to deliver a minimum of 225 drums and a maximum of 300 drums per delivery.
	*	•	Bidders are still required to deliver the minimum number of bags per delivery. Excess number of bags delivered shall not be deducted from the minimum bags required for the succeeding deliveries except when the remaining number of bags for the next delivery is less than the outstanding number of bags to be delivered due to previous excess deliveries.
		•	Payment of Laboratory Testings per delivery at third- party laboratory Testing Center shall be borne by the supplier
