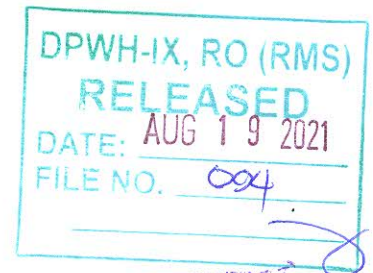

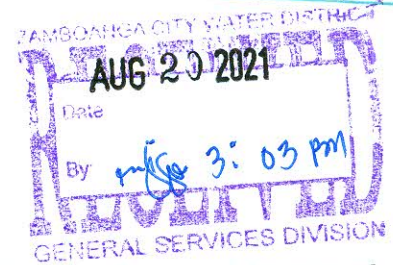

Dear Engr. De Fiesta:



This is with reference to your letter dated July 23, 2021, regarding the Proposed Laying of Feederline from Luyahan Production Well to Bypass Road and Relocation of Existing Cluster Connection Project, requesting for approval of concrete cutting, breaking and excavation works across the newly concreted Bypass Road in Luyahan, this City.

Please be informed that this office interposes **no objection** to your request with the following conditions:

1. Installation of interconnections/fittings shall be done outside the 20.00 meters Road-Right of Way limit.
2. Width of concrete to be cut shall be 1.50 meters from the existing weakened plane joints of the existing concrete pavement. (Please See Sketch Plan.)
3. Restoration work shall be done in accordance to DPWH Specifications and Standards.

Further, it is suggested that the above undertaking/activities shall be in proper coordination with the designated DPWH Project Engineer.

We look forward for your full cooperation on this matter.

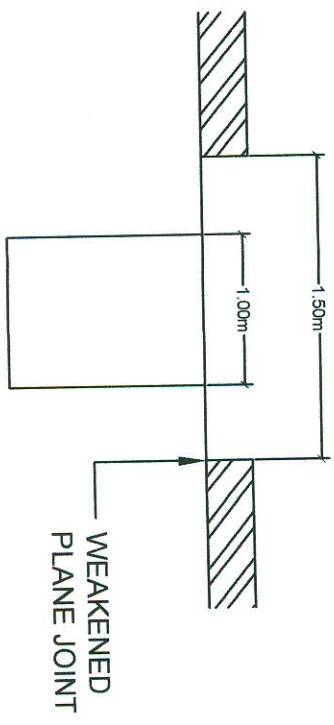
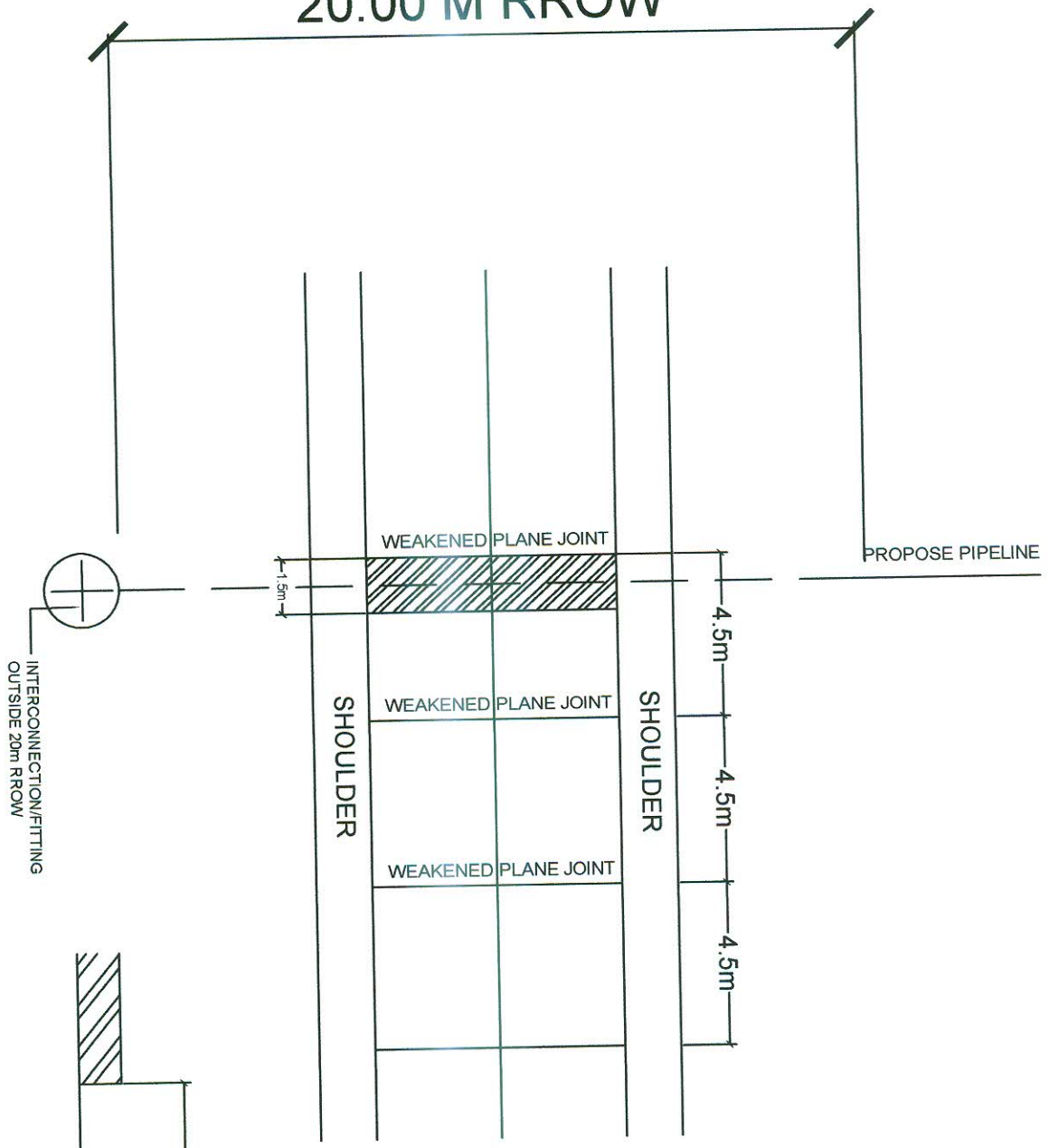


SUBJECT : Request for Excavation Permit

Referred is the letter from Marli P. Acosta – De Fiesta dated July 23, 2021 (copy attached) together with other documents in support to their request for the issuance of excavation permit.

Please be informed that, under Item No. 5 of Department **Order No. 26, series of 2011 also known as the Policy on Diggings/Excavations by Private and Public Utilities on National Roads**, states that "All requests for excavation permits, regardless of amount, will be processed by the concerned District Engineering Office, who shall in turn, recommend the approval thereof to the Regional Director."

Further, under **Department Order No. 124, series of 2014**, which amended D.O. No. 26, series of 2011, the authority for requests to approve excavation permits with restoration costs of Php500,000.00 and below, on areas outside the carriageway **was devolved to the appropriate District Engineer**. Subsequently, the approval for the program of works and /or detailed estimates for the restoration works shall also be under the purview of the concerned District Engineer.
