You are therefore required within ten (10) days from receipt of this Notice of Award to formally enter into contract with us and to submit performance security (Section 39.2 of the 2016 Revised Implementing Rules and Regulations (2016 RIRR) of RA No. 9184) in any of the form stated hereunder.

Moreover, pursuant to **6.4 of Government Procurement Policy Board (GPPB) Resolution No. 09-2020, dated 07 May 2020**, your company may submit a **Performance Securing Declaration (PSD)**, in lieu of a performance security enumerated in Section 39.2 of the 2016 Revised IRR of RA No. 9184, to guarantee your faithful performance of obligations, subject to the conditions stated therein.

The submission of PSD in lieu of the Performance Securities under Section 39.2 of the 2016 Revised IRR of RA No. 9184 is a temporary measure that is allowed during a State of Calamity or implementation of community quarantine or similar government restrictions. (*Item 3., p. 4 of GPPB Resolution No. 09, s. 2020*)

However, in the event that the state of calamity or community quarantine or similar restrictions shall be lifted, you shall be required to submit/replace the submitted PSD with a Performance Security in any of the prescribed forms under the said Section 39.2 of the 2016 Revised IRR of RA No. 9184.

Failure to enter into contract or to provide the Performance Security shall constitute a sufficient ground for cancellation of this award.
