The submission of PSD in lieu of the Performance Securities under Section 39.2 of the 2016 Revised IRR of RA No. 9184 is a temporary measure that is allowed during a State of Calamity or implementation of community quarantine or similar government restrictions. (Item 3., p. 4 of GPPB Resolution No. 09, s. 2020).

However, in the event that the state of calamity, or community quarantine or similar restrictions were being lifted, you are required to submit/replace the submitted PSD with a Performance Security in any of the prescribed forms under the said Section 39.2 of the 2016 RIRR of RA No. 9184.
