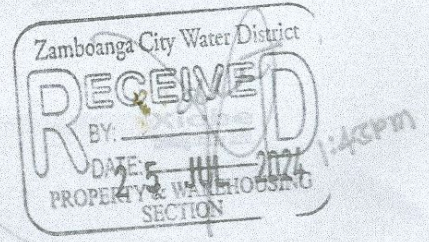

Please be informed that the contract for the items enumerated and specified in Purchase Request No. 24-0126 dated May 15, 2024, for the Contract Price equivalent to Seventy Three Thousand Three Hundred Pesos (Php 73,300.00) is awarded to **CONSTECH ASIA CORPORATION**.

You are therefore required within 10 (Ten) days from receipt of this Notice of Award to formally enter into contract with us and to submit performance security (Section 39.2 of the 2016 Revised Implementing Rules and Regulations (2016 RIRR) of RA No. 9184) in any of the form stated hereunder.

Moreover, pursuant to 6.4 of Government Procurement and Policy Board (GPPB) Resolution No. 09-0202 dated 7 May 2020, your company may submit a Performance Securing Declaration (PSD) in lieu of a performance security enumerated in Section 39.2 of the 2016 RIRR of RA No. 9184 to guarantee your faithful performance of obligations, subject to the conditions stated therein.

The submission of PSD in lieu of the Performance Securities under Section 39.2 of the 2016 Revised IRR of RA No. 9184 is a temporary measure that is allowed during a State of Calamity or implementation of community quarantine or similar government restrictions. (Item 3., p. 4 of GPPB Resolution No. 09, s. 2020).

However, in the event that the state of calamity, or community quarantine or similar restrictions were being lifted, you are required to submit replace the submitted PSD with a Performance Security in any of the prescribed forms under the said Section 39.2 of the 2016 RIRR of RA No 9184.

Failure to enter into contract or to provide the Performance Security shall constitute a sufficient ground for cancellation of the award.
