

This is to inform you that the contract for the items enumerated and specified in Purchase Request No. 24-0211 dated August 15, 2024, for the Contract Price equivalent to Three Million Three Hundred One Thousand Nine Hundred Twenty Pesos (Php 3,301,920.00) is awarded to PHILIPPINE VALVE MANUFACTURING CO.

You are therefore required within 10 (Ten) days from receipt of this Notice of Award to formally enter into contract with us and to submit performance security (Section 39.2 of the 2016 Revised Implementing Rules and Regulations (2016 RIRR) of RA No. 9184) in any of the form stated hereunder.

d) Any combination of the foregoing.	Proportionate to share of form with respect to total amount of security

Moreover, pursuant to 6.4 of Government Procurement and Policy Board (GPPB) Resolution No. 89-8282 dated 7 May 2828, your company may submit a Performance Securing Declaration (PSD) in lieu of a performance security enumerated in Section 39.2 of the 2016 RIRR of RA No. 9184 to guarantee your faithful performance of obligations, subject to the conditions stated therein.

The submission of PSD in lieu of the Performance Securities under Section 39.2 of the 2016 Revised IRR of RA No. 9184 is a temporary measure that is allowed during a State of Calamity or implementation of community quarantine or similar government restrictions. (Item 3., p. 4 of GPPB Resolution No. 09, s. 2020).

Failure to enter into contract or to provide the Performance Security shall constitute a sufficient ground for cancellation of the award.
