

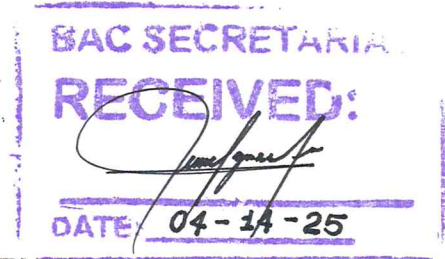

We are happy to notify that the contract for the items enumerated and specified in Purchase Request No. 24-0232 dated February 12, 2025, for the Contract Price equivalent to Sixteen Million Four Hundred Ninety Five Thousand Seven Hundred Seventy Four and 80/100 Pesos (Php 16,495,774.80) is awarded to **CZIANBENDICK ENGINEERING AND SUPPLIES**.

Moreover, pursuant to 6.4 of Government Procurement and Policy Board (GPPB) Resolution No. 09-0202 dated 7 May 2020, your company may submit a Performance Securing Declaration (PSD) in lieu of a performance security enumerated in Section 39.2 of the 2016 RIRR of RA No. 9184 to guarantee your faithful performance of obligations, subject to the conditions stated therein.

The submission of PSD in lieu of the Performance Securities under Section 39.2 of the 2016 Revised IRR of RA No. 9184 is a temporary measure that is allowed during a State of Calamity or implementation of community quarantine or similar government restrictions. (Item 3., p. 4 of GPPB Resolution No. 09, s. 2020).
