The submission of PSD in lieu of the Performance Securities under Section 39.2 of the 2016 Revised IRR of RA No. 9184 is a temporary measure that is allowed during a State of Calamity or implementation of community quarantine or similar government restrictions. 
Failure to enter into contract or to provide the Performance Security shall constitute a sufficient ground for cancellation of the award.
