Item No. 16 G.I. Bell Reducer 19mm x 12mm (Heavy Gauge)	Equivalent in inches is $\frac{1}{2}$ "
Item No. 50 Plastic Security Seal w/ 16" stainless sealing wire	With the following specifications: <ul style="list-style-type: none">• Stainless steel stranded wire• Color Blue• The initials ZCWD shall be engraved above the serial number on the seal wing• Serial Number shall start from for 22" wire 25-000001 to 25-002500
Item No. 51 Sealing Wire 16" (Stainless Steel Wire #7)	Wires only – 16" stainless steel wire

Samples for G.I. Pipes (Item Nos. 34, 35, & 36) must consist of cut-out pieces at least 6 inches long.
